Furthermore, RNM is committed to addressing the need to remove conditions that lead to abject poverty, cycles of disease, and ill health, especially among children and women through sustainable development. about 135 different volunteers for the Walk and some 85 attendees to the Gala Dinner fundraiser. We also used the Textedly Online Text Messaging and the September 9/11 Shell Oil Company Heroes Program to help us raise some matching funds to reach the minimum public support level of 33% of the funds raised in 2023 as well as during the "Giving Tuesday" cause awareness in November. The majority of our funds came from the 3-year grants from the Giles family foundation. We also got a few specific water well project funding from individual donors and partners like the Dominion Church in Dickinson, Texas that partnered with RNM to do a few projects early in 2023. Some of our drilling equipment that were out of service and aging badly were sold in late 2023 and the funds applied towards well drilling projects, and our Workshop site construction in Nigeria. RNM also funded the remodeling of the Boys Orphanage in India, built them a toilet, and drilled a new well at their location that is shared with the villagers in CHIBROLE and helped renovate the church they attend. Similarly, the first Orphanage building construction was helped with funding to do some foundation work and pillar installation before the local leaders paused the project citing some need for a particular permit. Our teams continue to work on Health & Hygiene education everywhere to make significant hygiene behavior changes among women and children in the WASH programs. Overall, we completed some 45 well projects (new, and rehabs) with some 38 well site visits in both countries to prior year projects to ensure their functionality, reinforce hygiene training, provide food, and gifts of clothing, etc. as we share the gospel of Christ as the need arises and among those interested in learning more about the love of Jesus Christ.
